Taken from the seated position by someone who is physically disabled and unable to stand to take the photograph.</p> <p>2. <b>Reproduction rights</b><br/>Organizers reserve the right to reproduce any photograph entered, in newspapers, internet and other media to specifically promote the exhibition, acknowledge the photographers or to celebrate our being different, for a period of 2 years.</p> <p>3. <b>Book publication</b><br/>We will negotiate with individuals to reproduce any photo for use in a promotional book which will follow the exhibition. Permission will be sought in advance. (the book funds are to establish a trust fund for future exhibits).</p> | <p>4. Photos must be clearly labelled and received with the application in digital form with a <b>fee of \$5</b> .</p> <p>5. Each photo should have a story on separate sheet (about 100 words) eg How did you take it? What is it about? Does it have personal significance?</p> <p>6. Ideally the photo will show us the different view of typical daily activity but is not necessary as we are also keen to show the talents of the seated photographer.</p> <p>7. <b>Models and privacy</b> – it is up to entrants to obtain permission to use images of people and or recognizable property.
